In accordance with the provisions of Declaration of Restrictions originally recorded on November 6, 1959 at Docket 168, Pages 416-417 of the official records of Yavapai County, Arizona, the undersigned, being a majority of all the persons now owning any of the lots in Ho-Kay-Gan Village Subdivision and being eligible and empowered to do so, do hereby agree to amend paragraph 8 of the original Declaration of Restrictions as follows:

8. Not more than three (3) horses may be kept by any one owner and then only by owners of lots in excess of 70,000 square feet which have designated stable areas. Owners of lots with designated stable areas that have less than 70,000 square feet may keep not more than two (2) horses. Other owners of lots in this subdivision shall not keep or maintain horses on their lot.


